

Potential Earnings

Fee structure is provided to us by the Department of Defense. Each family's income is validated and a fee is assigned according to their total family income.

A provider caring for an eligible military / DOD child will receive payment from the parent and from subsidy totaling:

- \$1,200 per month for children under 24 months
- \$1,000 per month for children 2-5 years
- \$680 per week for Before / After School
- \$1,000 per month for summer school age care
- \$15 per hour for extended care
- Drop-in care is negotiated between provider and parent
- \$250 each quarter initial certification incentive during your first year with full time care.
- \$500 Transfer Incentive

Basic Qualifications

- At least 18 years of age.
- Responsible, emotionally stable, and capable of exercising good judgement in caring for children.
- Have a high school diploma, GED, or higher level degree.
- Speak, read, and write English fluently to communicate with parents.

As you complete the certification process for becoming a Navy FCC Provider, you'll have help every step of the way.

First, you'll need to complete a certification application and submit it to your local Navy FCC Office. Then we will contact you to get the ball rolling for:

- Background check screening of you and eligible family members.
- Family interview
- Physical exam and proof of updated immunizations
- Initial orientation and training
- Initial home inspection, including fire and Preventive Medicine

About Family Child Care (FCC)

Family Child Care (FCC) assist parents by providing child care services to support operational readiness, mission accomplishment and retention

Family Child Care (FCC) Homes are an alternative to center-based care and often preferred by families because of the small group sizes, the home-like atmosphere and the flexible hours of operation that other centers often cannot accommodate. Anyone who lives in military housing and wishes to provide child care on a regular basis for more than ten hours a week must be certified by the Navy as a FCC Provider.



Types of Family Child Care Programs

Multi-Age Homes

Serve no more than six children at one time including the provider's own children under the age of eight years old. In a multi-age group, no more than two children under the age of two (whether they are the patron's or the provider's) may be cared for in one home.

Infant/Pre-Toddler Homes

Provider may care for infants six weeks old to 24 months of age. There shall only be one child under two months of age. Group size shall never exceed three children.

Before & After School Homes

Provides care for children five to 12 years of age. If all children in care are older than five years of age (including the provider's own) the maximum group size shall never exceed eight children.

Extended Hours Homes

Serve parents who require routine evening care, work unusual / long hours and have mission related child care needs not to exceed 72 consecutive hours.

Special Needs Homes

Offer appropriate care to one or more children with identified needs.
