## Step 5 - FIRE DEPARTMENT

### Step 6 - CFAY LEGAL

- o Food handler certificates (if applicable) (PREVENTIVE MED.)
- o Pre-filled, unsinged, Hot Work Permit (if applicable) (FIRE)

## Step 7 - COMMISSARY

All food orders must be placed with the Commissary a minimum of **8 weeks** prior to event date for guaranteed delivery.

Bread must be paid for at the time the order is placed. **Items may not be returned after purchase.** Order form may be obtained from Vendor Meetings, requesting at the Commissary, or by visiting www.NavyMWRYokosuka.com.

#### Step 8 - MWR

There is a mandatory \$350 registration fee to participate.

Once approved and confirmed by CFAY Legal, registration fees can be paid at the MWR Tickets & Travel Office. This is located on the first floor of Building 1559 (near Starbucks).
