Only current home based businesses in good standing will be allowed to apply.

Event application package deadline is **10 April**.

Payment of \$100 is due to MWR Tickets & Travel by **24 April**.

Completed packages must be turned in to CFAY Legal.

### **Step 1 – CFAY LEGAL**

Is your home based business registered and approved to operate onboard CFAY?

- YES = Please go to Step 2
- NO, we are not approved to operate = Please fill out a **Request to Conduct Commercial Activities or Private Employment from Military Family Housing or On Board Fleet Activities, Yokosuka**. ### **Step 2 – CFAY LEGAL**

### **Step 3 – PREVENTATIVE MEDICINE - TFE**

Will your organization be handling or preparing food?

- YES = Complete **Temporary Food Establishment Form** and obtain Temporary Food Establishment Form DD-2970 form from Preventative Medicine
  - Food not sourced from approved sources (e.g. Commissary & NEX) must be added to this form for approval from Army Vet
  - Valid (through date of event) Food Handlers certificate must be included with DD-2970 submission for all members who are preparing and/or handling food.
  - Next Temporary Food Handlers Course:
    - 27 March 2026

### **Step 4 – FIRE DEPARTMENT**

Will your business be using any kind of open flame on site at this event?

- YES = Please fill out a **Hot Work Permit**. Please email [MWR\\_Yokosuka\\_Special\\_Events@us.navy.mil](mailto:MWR_Yokosuka_Special_Events@us.navy.mil) to request a copy. Fill out the permit, and have a Fire Inspector from the Fire Dept. review and sign on the day of event. **Only a pre-filled copy is needed for the application packet.**
- NO = Please go to Step 6.

### **Step 5 – CFAY LEGAL**

Provide the following to CFAY Legal for processing by **10 April**:

- Approval letter (CFAY LEGAL)
- Food handler certificates (if applicable) (PREVENTIVE MED.)
- Signed Temporary Food Establishment Form (if applicable) (PREVENTIVE MED./ ARMY VET)
- Pre-filled Hot Work Permit (if applicable) (FIRE)
- Completed Fundraising Request form (CFAY LEGAL)

**Step 6 - MWR**

There is a mandatory **\$100**, registration fee needed to participate. This fee covers the cost of (1) 10x10 canopy, (1) 8-Foot Table, and (2) Chairs. Limited Power will be available for this event and power request must be detailed during sign up.

Once approved and confirmed by CFAY Legal, registration fees can be made at our **MWR Tickets & Travel Office**. This is located in BLDG 1559 and is a credit/debit only facility.
